# 5. Resolution: Student fees for 2021-2022

The DCC and guest MP Beaumont presented the adjustments to the Student Fees for 2021-2022. These fees will also be updated in Bylaw 6.

Resolution No.: LAW-2020-011

Bylaw 6 revision regarding student fees - St. Lawrence

**WHEREAS** the Regulation respecting the tuition fees that a general and vocational college must charge has been updated; and

**WHEREAS** modifications to the following student fees for implementation as of the fall 2021 semester are being proposed:

- Auxiliary Service Fee for full-time students: from \$155 to \$165
- Auxiliary Service Fee for part-time students: from \$35 to \$37

**BE IT THEREFORE RESOLVED** that the Governing Board of Champlain - St. Lawrence approves the proposed modifications to Bylaw Number 6 regarding student fees for application as of the fall 2021 semester and recommends their adoption by the Board of Governors.

# 6. Update on the COVID situation

The DCC presented an update to the board members on the following items:

- End of fall semester and preparation for the winter semester
  - The failure rates / success rates were presented and information with respect to the incompletes during the special situation (COVID) was also provided. Overall, although there is an increase in incompletes, the success rates remain good. The success rate for students that completed all their courses remains very good as well.
  - o Enrolment figures for the winter semester remain quite stable although courses were and will continue to be given online. St. Lawrence has its highest winter enrolment of the last years.
  - Essential services only will be on campus such as IT, cleaning, building services, library and labs
  - o An update on the virtual Open House activities was provided. The event went very well.
  - o Information was asked about the success rates of first semester students. Also the comparison of the overall averages for this year versus past years was also requested. It will be provided at the next Board.
  - o The College is monitoring summer classes that may be required by certain students.
  - The Chair requested that the data be sent to the board members in advance whenever possible.
- Input from student representatives on the Board
  - o An update is provided by the student representatives on the well-being and appreciation of the students with respect to the winter semester.
